On November 14, 2002, Sunrise Well Association (the "Association" or the "Applicant") filed with the Arizona Corporation Commission (the "Commission") an application for adjudication that it is not a public service corporation under Arizona law. On August 12, 2003, the Commission issued a Procedural Order that, among other things, (1) set a hearing date of November 13, 2003 for the above-captioned matter (the "Hearing"), and (2) ordered the Commission's Utilities Division Staff (the "Staff") to prepare a Staff Report on or before September 25, 2003.

The Staff Report was docketed on September 29, 2003. Pursuant to the Staff Report, Staff could recommend that the Applicant be adjudicated not a public service corporation upon the Applicant providing evidence that (1) each member/customer of Applicant has equal voting rights in the Association, and (2) the Association has direct ownership of the water production, storage and distribution assets necessary to serve the Association's customers/members.

In response to the conditions set forth in the Staff Report, the Association filed that certain

1 Compliance Filing on November 10, 2003, which such filing included, among other items, a copy
2 of an executed but unrecorded quitclaim deed pursuant to which Dale P. Nash and Phyllis C.
3 Nash, as trustees of the R. & M. Family Trust (the "Trust"), conveyed to the Association any and
4 all interest the Trust had in that certain real property located in Mohave County, Arizona and any
5 improvements and appurtenances thereto (collectively, the "Property"). In further support of its
6 request to be adjudicated not a public service corporation, the Association hereby files a copy of a
7 fully executed quitclaim deed, attached hereto as Exhibit A, conveying to the Association any and
8 all interest in and to the Property held by the Trust, dated as of September 13, 2003, and recorded
9 on November 4, 2003, in the official records of Mohave County, indexed as Instrument No.
10 2003094246 in Book 4279 at Page 148.
