4 have to use our billing address/billing name or our right  
5 address. Our P.O. Box 2771 is our right address according  
6 to the Head/Chief of the Postal Service.

7           5. Prove that that P.O. Box is not my postage box,  
8 and that I do not use it as you cannot do so.

9           6. Prove that you have not violated our state and  
10 constitutional rights to express our opinions and facts to  
11 the public, to the company causing this, to the commission  
12 and to others.

13           **WHEREFORE;** You will find you have violated our  
14 rights, so we request at this time that in reciprocation of  
15 violating our rights, that restitution be made to our group  
16 of citizens opposing this increase; and that the water rates  
17 not be increased or you will force us to take this to a much  
18 higher court/proceeding than this. Also, since I just  
19 arrived home with proof to find this awaiting, this is the  
20 first chance we have had to respond, and therefore it is  
21 timely as you sent this notice out non-registered, and to no  
22 other customers or parties and it is filed well before the  
23 June 23, 2003 hearing.
