PROCEDURAL ORDER

**BY THE COMMISSION:**

On August 14, 2002, Arizona Water Company ("AWC") filed with the Arizona Corporation Commission ("Commission") an application for an increase in its rates.

On October 23, 2002, a Procedural Order was issued setting the application for hearing on June 23, 2003, and establishing associated procedural deadlines.

On February 27, 2003, the Commission's Utilities Division Staff ("Staff") filed a Motion to Continue all Procedural Deadlines, Continue Hearing, and for Tolling of the Rate Case Time-Clock ("Motion").

Intervenor Residential Utility Consumer Office ("RUCO") filed a response to the Motion on February 27, 2003, stating that it has no objection to the Motion.

On March 5, 2003, AWC filed a response requesting that the Motion be denied.

On March 10, 2003, Staff filed a reply in support of its Motion.

It is appropriate for the parties to have an opportunity to present oral argument in support of their positions on the issues set forth in the Motion, the responses, and the reply.
