PROCEDURAL ORDER

**BY THE COMMISSION:**

On August 14, 2002, Arizona Water Company filed with the Arizona Corporation Commission ("Commission") an application for an increase in its rates.

On February 25, 2003, a Motion to Intervene was filed in these dockets signed "Michelle Byers" ("Motion"). The Motion stated, however, that Michelle Byers is not the movant's correct name, and that the address provided in the Motion is not the movant's correct address.

No parties objected to the Motion. However, because the movant has not provided a correct name or address, the Motion cannot be granted. Instead, the Motion, which is a part of the Commission's permanent files in this case, should be considered as public comment.

IT IS THEREFORE ORDERED that the February 25, 2003, Motion to Intervene filed in these dockets signed "Michelle Byers" is hereby denied.


