PROCEDURAL ORDER

BY THE COMMISSION:

Citizen Utilities Company's ("Citizens") requested a brief continuance of the hearing date in this matter and a slight modification of the testimony schedule that were set in our Procedural Order dated April 6, 2000. Neither Arizona Corporation Commission Staff nor RUCO objected to Citizen's request, and the matter will not be significantly delayed nor any party prejudiced by Citizen's request.




