**PROCEDURAL ORDER**

**BY THE COMMISSION:**

At the pre-hearing conference on April 6, 2000, the parties stated that they had reduced the unresolved issues related to Citizen Utilities Company's ("Citizens") Stranded Cost recovery plan to one or two. The parties were in agreement that the matter should be set for hearing and agreed to the schedule set forth hereinbelow. The parties expressed some optimism that they would be able to resolve all the outstanding issues related to Stranded Cost recovery and present a Settlement Agreement between Citizens, Commission Staff and RUCO for approval.

IT IS THEREFORE ORDERED that a hearing on Citizen's proposed Stranded Cost recovery plan shall commence on **June 21, 2000 at 10:00 a.m.**, at the Commission's offices located at 1200 West Washington, Phoenix, Arizona.

IT IS FURTHER ORDERED that Citizens shall file revised direct testimony and associated exhibits to be presented at hearing in support of its Stranded Cost recovery plan and/or Settlement Agreement on or before noon on **May 15, 2000**.

IT IS FURTHER ORDERED that Commission Staff and interested parties shall file responsive testimony and associated exhibits or comments on or before noon on **June 6, 2000**.

1 IT IS FURTHER ORDERED that Citizens shall file any rebuttal testimony and associated  
2 exhibits on or before noon on **June 12, 2000**.

3 IT IS FURTHER ORDERED that Staff and interested parties shall file any surrebuttal  
4 testimony and associated exhibits on or before noon on **June 19, 2000**.
