PROCEDURAL ORDER

**BY THE COMMISSION:**

On March 7, 2000, a telephonic status conference was held to determine whether the parties had reached a settlement of the issues related to Citizens Utilities Company's ("CUC") Stranded Costs and to determine whether the matter should be set for hearing. The parties reported they had narrowed the remaining unresolved issues to one or two and that they believed another status conference in about a month would be appropriate and beneficial to the process. CUC expressed a desire to circulate the proposed agreement among interested parties who were not present at the status conference and who had not heretofore participated in the settlement discussions prior to the next status conference.

IT IS THEREFORE ORDERED that another telephonic status conference on the above captioned matter shall be held on **April 4, 2000, at 10:00 a.m.** for the purpose of determining the level of general agreement amongst interested parties for the proposed settlement and to set the matter for hearing.
