20 RE-00000C-94-0165, E-01032C-97-0774, and E-01749A-98-0468.

21 IT IS FURTHER ORDERED that ASARCO is hereby granted intervention in Docket Nos.
22 RE-00000C-94-0165, E-01032C-97-0774, E-01461A-98-0466, E-01461A-97-0696 and E-01773A-
23 98-0470.


