PROCEDURAL ORDER

BY THE COMMISSION:

On July 19, 2001, the Securities Division ("Division") of the Arizona Corporation

1 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order  
2 for Relief ("Notice") against Hotel Connect, LLC ("Hotel"), Mark Alan Melkowski, Eagle  
3 Communications, Inc., Ronald Lee Goble, individually and dba Southwest Trust & Financial  
4 ("STF"), Gary Lyle Christian, individually and dba Cornerstone Senior Planning ("Cornerstone"),  
5 Hyland A. Stokes, individually and dba Estate Planning Protection ("ESP"), Roger Lancette,  
6 individually and dba National Advisory Services and Senior Advisory Services ("Advisory") and  
7 Wallace Butterworth, individually and dba Senior Advisory Services ("SAS"), (collectively the  
8 "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act  
9 ("Act") in connection with the offer and sale of securities in the form of membership interests in  
10 Hotel Connect.

11 The Respondents were all duly served with copies of the Notice.

12 On July 24, 2001, Respondent Wallace Butterworth filed a request for hearing.

13 On July 26, 2001, Respondent Gary Christian filed a request for hearing.

14 On July 31, 2001, Respondent Ronald Goble requested a hearing.

15 On August 3, 2001, Respondent Hyland Stokes requested a hearing.

16 On August 16, 2001, Respondent Roger Lancette requested a hearing.

17 Accordingly, a pre-hearing conference should be held on the allegations contained in the  
18 Notice.

19 IT IS THEREFORE ORDERED that a pre-hearing conference shall be held on September 13,  
20 2001 at 10:00 a.m., at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


