

13) **PROCEDURAL ORDERS**

14 On January 13, 1998, Arizona Public Service Company ("APS") filed a Motion to Amend
15 the Procedural Orders ("Motion") relating to the February 9, 1998 Generic Stranded Cost Hearing.
16 In its Motion, APS requested that the deadline for the parties to file rebuttal testimony be extended
17 until February 7, 1998.¹ For the reasons set forth in the Motion, TEP generally supports APS'
18 request for additional time. However, TEP believes that it needs at least one business day prior to
19 commencement of the hearing to review the rebuttal testimony. Therefore, TEP proposes the
20 following. As a Procedural Conference is already scheduled for February 5, 1998 at 1:30 p.m., TEP
21 suggests that all parties file their rebuttal testimony by such time and be directed to simultaneously
22 exchange rebuttal testimonies at the Procedural Conference. To the extent a party does not attend the
23 Procedural Conference but will be filing rebuttal testimony, such parties should be directed to
24 overnight or facsimile their testimony to ensure that it is *received* by all other parties no later than
25 5:00 p.m. February 5, 1998.

1 TEP does not support APS' suggestion that cross examination for rebuttal witnesses be
2 deferred. TEP has two outside witnesses that will only be available to testify once and will require a
3 date certain for their testimony.
