FINDINGS OF FACT

1. Southwest Gas Corporation ("Southwest") is engaged in providing natural gas service within portions of Arizona, pursuant to authority granted by the Arizona Corporation Commission.

2. On November 24, 2006, Southwest filed for Commission approval of revisions to its rate schedule number T-1, Transportation of Customer-Secured Natural Gas (T-1 tariff). Southwest cites a need to conform its tariff to recent changes implemented by El Paso Natural Gas Company on its interstate pipeline system.

3. In Decision No. 69203 (December 21, 2006), the Commission suspended this filing for 120 days, through and including April 24, 2007, to provide Staff with additional time to analyze the filing.




