

**BY THE COMMISSION:**

12 Having considered the entire record herein and being fully advised in the premises, the  
13 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

14 **FINDINGS OF FACT**

15 1. On September 7, 2000, in Decision No. 63613, the Commission granted to Universal  
16 Access, Inc. ("Applicant") a Certificate of Convenience and Necessity ("Certificate") authorizing it  
17 to provide competitive resold interexchange telecommunications services, and resold local exchange  
18 services.

19 2. On January 16, 2007, Applicant filed with the Commission an application to cancel its  
20 Certificate. The application stated that Applicant has ceased operations and has no  
21 telecommunication customers or subscribers in the State of Arizona.

22 3. On March 28, 2007, the Commission's Utilities Division Staff ("Staff") filed a Staff  
23 Report in this matter.

24 4. In the Staff Report, Staff verified that Applicant does not service any Arizona  
25 customers and is no longer doing business in Arizona. Staff stated that Applicant is not holding any  
26 prepayments, deposits, or advances and no customers in Arizona would be at risk by cancellation of  
27 Applicant's Certificate. In addition, Staff stated that there are numerous other carriers offering  
28 services similar to Applicant's in Arizona.
