PROCEDURAL ORDER

BY THE COMMISSION:

On December 12, 2006, Golden Shores Water Company, Inc. ("Company" or "Applicant"), filed with the Arizona Corporation Commission ("Commission") an application for the approval of long-term debt in Docket No. W-01815A-06-0775.

On February 23, 2007, the Company filed with the Commission an application for the approval of a permanent rate increase in Docket No. W-01815A-07-0117.

Subsequently, the Commission's Utilities Division ("Staff") issued a Notice of Insufficiency, with respect to the rate proceeding, pursuant to A.A.C. R14-3-103.

On April 27, 2007, Staff filed a Motion to Consolidate Dockets ("Motion") in the above-captioned proceedings since they are substantially inter-related. Further, Staff indicated the Company does not object to the Motion for the consolidation of these proceedings.

Accordingly, pursuant to A.A.C. R14-3-109, these proceedings should be consolidated.

IT IS THEREFORE ORDERED that the above-captioned proceedings shall be consolidated.

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive  
2 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
