**RENEWAL OF MOTION FOR ARBITRATION ORDER ADOPTING INTERCONNECTION AGREEMENT, FOLLOWING ANSWERPHONE'S FAILURE TO RESPOND**

By Procedural Order issued on March 26, 2007, the Arbitrator ordered Answerphone, Inc. ("Answerphone") to file by April 9, 2007, Answerphone's response to the Motion of Qwest Corporation ("Qwest") for Adoption of Arbitration Order. The Arbitrator's Procedural Order stated, "If Answerphone fails to file a response by April, 9, 2007, Qwest's Motion may be granted and the interconnection Agreement attached as Exhibit B to the Petition may be approved as submitted." The Procedural Order also allowed for the Commission Staff ("Staff") to file any comments it may have by April 16, 2007. Answerphone did not file any response, and the Staff has not filed comments.

Consequently, Qwest respectfully renews its Motion for an Arbitration Order Adopting the Interconnection Agreement proposed by Qwest in its Petition, for the reasons stated in the
