Pursuant to A.A.C. R14-3-110 (B), Mesquite Power, L.L.C., Southwestern Power Group II, L.L.C., Bowie Power Station, L.L.C. and Sempra Energy Solutions ("M/S/B/S") submit their "Exceptions" to the recommended Opinion and Order ("ROO") issued by Administrative Law Judge Jane L. Rodda in the above-captioned proceeding.

M/S/B/S support the ROO as issued by Judge Rodda. In addition, they support the two (2) additional Ordering Paragraphs which have been proposed by Local Union 1116, International Brotherhood of Electrical Workers, AFL-CIO, CLC ("IBEW Local 1116"). M/S/B/S agree with IBEW Local 1116 that addition of the aforesaid two (2) Ordering Paragraphs to the ROO would contribute to judicial (and administrative) economy in connection with the future conduct of the above-captioned proceeding and the forthcoming Rate Proposal Docket. Consistent in this regard is Finding of Fact No. 95 in the ROO, which recommends that

"The Rate Proposal Docket will be consolidated  
with this Docket and proceeding."

In addition, M/S/B/S request that the service list client representation information on page 23 of the ROO, as it pertains to the undersigned, be revised to be consistent with the client representation information set forth in Finding of Fact No. 19 of the ROO. At present, the service list client representation information does not include Mesquite Power, L.L.C., Bowie


