**PROCEDURAL ORDER**

**BY THE COMMISSION:**

On November 9, 1999, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("Temporary Order") and Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") against Safari Media, Incorporated ("SMI"), Mrs. Maryann Chisholm, Mr. Mark Fillmore Chisholm, and Mr. Thuc Nguyen in which the Division alleged multiple violations of the Securities Act in connection with the offer and sale of securities in the form of shares of stock.




