**STAFF REQUEST FOR EXTENSION
OF TIME TO FILE COMMENTS**

On October 25, 2006, Qwest filed a Motion to Re-Open Arbitration with Respect to Answerphone, Inc. Qwest had discovered that since the dismissal of Answerphone from the proceeding, "Answerphone continues to operate as a wireless provider of paging services, and has continuously been interconnected with Qwest throughout the relevant time periods of this proceeding."

On November 3, 2006, the Commission reopened the arbitration with respect to Answerphone and ordered Answerphone to file a response to Qwest's Motion to Re-Open by November 16, 2006. Answerphone did not file a Response.

On February 22, 2007, Qwest filed a Motion for Arbitration Order adopting Interconnection Agreement. Answerphone again did not file a Response to Qwest's Motion.

Staff seeks an extension of time to file its response or comments, including procedural recommendations, until Friday, May 18, 2007.


