PROCEDURAL ORDER

BY THE COMMISSION:

On March 7, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Owen A. Vilan and Lucina Vilan, husband and wife, and Saguaro Investments, Inc., fka Vilan Enterprises, Inc. ("SIVE") (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

Respondents were duly served with copies of the notice.

On April 9, 2007, Respondents filed a request for a hearing.

On April 12, 2007, by Procedural Order, a pre-hearing conference was scheduled for May 7, 2007.

On May 7, 2007, the Division and Respondents appeared through counsel. Counsel discussed the status of the proceeding and agreed to a status conference being scheduled in July. Accordingly, a status conference should be scheduled in July 2007.
