SECOND PROCEDURAL ORDER

BY THE COMMISSION:

On March 20, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Leonard Francis Alcaro and Mary Brigid Lavin Alcaro, (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale investment contracts and/or promissory notes.

Respondents were duly served with copies of the notice.

On April 9, 2007, Mary Brigid Lavin Alcaro filed a request for a hearing.

No request for hearing has thus far been filed on behalf of Leonard Francis Alcaro.

On April 12, 2007, by procedural order, a pre-hearing conference was scheduled on May 7, 2007.

On May 7, 2007, the Division and Respondent Mary Alcaro appeared through counsel. The attorney appearing for Mrs. Alcaro indicated that he was substituting for Mrs. Alcaro's attorney of record because he is out of the country until June 11, 2007. The Division's counsel agreed that another pre-hearing conference should be scheduled in late June.

Accordingly, a second pre-hearing conference should be scheduled on the allegations

1 contained in the Notice.

2 IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **June 28,**
3 **2007, at 9:30 a.m.,** at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

4 IT IS FURTHER ORDERED that, in the event counsel for Mrs. Alcaro wishes to appear
5 telephonically, he must contact, **at least three days prior to the above-scheduled pre-hearing**
6 **conference,** the Commission's Hearing Division at 602-542-4250, for instructions on how to appear
7 telephonically.


