On April 27, 2007, Vanco filed an application for approval to inform the Commission of a transaction whereby Lloyds TSB Bank PLC will make available to Vanco and certain of its affiliates, the sum of 100 Million Pounds Sterling which will be secured by the guarantee of Vanco, a security interest in Vanco's assets and pledge of Vanco's membership interests in Docket No. T-20404A-07-0261.

On August 22, 2005, Vanco Direct USA, LLC ("Vanco" or "Company") filed an application for approval of a Certificate of Necessity and Convenience to provide resold long distance telecommunications services and resold local exchange telecommunications services for the state of Arizona in Docket No. T-20404A-05-0599.
