FIFTH
PROCEDURAL ORDER

BY THE COMMISSION:

On November 18, 2002, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to Cease and Desist, for Restitution, for Administrative Penalties, and For Other Affirmative Action ("Notice") against John R. Wallrich and Jane Doe Wallrich ("Respondents") in which the Division alleged that Respondent have engaged in acts, practices, and transactions that constitute violations of the Arizona Securities Act ("Act").

On May 6, 2003, by Procedural Order, a hearing was set in this matter for August 26, 2003.

On August 11, 2003, a Joint Motion to Continue Hearing was filed.

Accordingly, the hearing set for August 26, 2003 should be rescheduled.

IT IS THEREFORE ORDERED that the hearing scheduled for August 26, 2003 is vacated and rescheduled to October 6, 2003 at 10:00 a.m. at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.

IT IS FURTHER ORDERED that the parties shall exchange witness lists and exhibits no later than September 2, 2003 and provide a copy of same to the presiding Administrative Law Judge.

IT IS FURTHER ORDERED that the Ex Parte Rule is still in effect.

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend or waive
2 any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.


