12 On November 18, 2002, the Securities Division ("Division") of the Arizona Corporation
13 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to
14 Cease and Desist, for Restitution, for Administrative Penalties, and For Other Affirmative Action


