11 **BY THE COMMISSION:**

12 On November 18, 2002, the Securities Division ("Division") of the Arizona Corporation
13 Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order to
14 Cease and Desist, for Restitution, for Administrative Penalties, and For Other Affirmative Action
15 ("Notice") against John R. Wallrich and Jane Doe Wallrich ("Respondents") in which the Division
16 alleged that Respondent have engaged in acts, practices, and transactions that constitute violations of
17 the Arizona Securities Act ("Act").




