The Council has, during the Stranded Costs hearings, prepared and presented briefs, arguments, testimony and intervened and appeared on behalf of residential, small business, rural and other vulnerable consumers before the hearing officer and the Corporation Commission as a party in interest in proceedings relating to electric deregulation.

Residential, small business, rural and other vulnerable consumers of Citizens Utility Company will be directly and substantially affect by a Decision or Order of the Commission in this matter., therefore, it is necessary and proper that the Arizona Consumers Council intervene in this proceeding.
