MOTION TO EXPEDITE

13 Pine Water Company ("PWCo") hereby files this Motion to Expedite in the above-
 14 captioned matter. PWCo requests that the Arizona Corporation Commission process this
 15 application for specific approvals required by law in an expedited manner in recognition
 16 of the fact that the location and development of a new and sustainable water source for the
 17 Pine-Strawberry area as expeditiously as possible is in the public interest. Commission
 18 approval is a predicate for initial funding of the well project by Pine Strawberry Water
 19 Improvement District ("PSWID").

20 PWCo is aware of the Commission's concerns over strained resources, and is
 21 sensitive to the burden on time and resources that expediting this Application may create.
 22 However, given the current drought conditions in Arizona, the sooner new water sources
 23 are found, the better circumstances will be for PWCo and its customers. Prompt action by
 24 the Commission will increase the possibility that a new water source will be available for
 25 the summer of 2008.


RELIEF REQUESTED


