Respondents Edward and Maureen Purvis move this court for an extension of 90 days on the hearing in this matter.

Mr. Purvis was recently indicted and arrested on charges related to the individuals and persons in this matter. Notably, some of the charges brought against Mr. Purvis

1 allege that he improperly recorded liens and otherwise improperly used confidential
2 information related to the Corporation Commission's attorney in this matter and others
3 involved in the claims being asserted against him.

4 As a result of these issues, Mr. Purvis has been unable to meet with counsel and
5 effectively communicate with him with respect to the preparation of the defense. Further,
6 there may be conflict issues raised by the fact that counsel for the Corporation
7 Commission may be a witness in the criminal proceedings pending against Mr. Purvis.

8 There is no urgency to take this matter to hearing. The Court will recall it
9 promptly granted the ACC's request for an extension of this hearing. Equity and fairness
10 dictate that Mr. Purvis' request for an extension as requested herein be granted as well.


