PROCEDURAL ORDER

BY THE COMMISSION:

On November 24, 2006, Southwest Gas Corporation ("SWG") filed with the Arizona Corporation Commission ("Commission") for approval of revisions to its Rate Schedule No. T-1, transportation of customer secured natural gas.

On December 21, 2006, the Commission issued Decision No. 69203 which suspended the tariff filing through April 24, 2007.

On April 16, 2007, the Commission issued Decision No. 69406 which further suspended the tariff filing through August 22, 2007.

On May 7, 2007, Sierra Southwest Cooperative Services ("SSCS") filed an Application to Intervene.

There has been no objection to this request.

IT IS THEREFORE ORDERED that the request to intervene by SSCS is hereby granted.
