FINDINGS OF FACT

1. Garkane Energy Cooperative, Inc. ("Garkane" or the "Cooperative") is engaged in providing electric service within portions of Arizona, pursuant to authority granted by the Arizona Corporation Commission.

2. On February 5, 2007, Garkane filed for Commission approval of revisions to its Line Extension Policy ("Policy"). The revised Policy adds a new item to provide hook-up fees and includes a new hook-up fee schedule.

3. Garkane cites its objective to make its Arizona Policy consistent with the Policy applicable to the rest of its system in Utah, where hook-up fees are currently being assessed.

4. On February 9, 2007, Garkane, through its counsel, Michael M. Grant, filed a memorandum agreeing to suspend the time clock through and including May 11, 2007, to provide Staff with additional time to review Garkane's revised Policy.


