PROCEDURAL ORDER

BY THE COMMISSION:

On April 17, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Estate Protection Consultants, L.L.C dba Estate Protection Consultants ("EPC") and Ramon Conrado Villa Vasquez aka Ray C. Villa and Jane Doe Villa, husband and wife (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of notes.

Respondents were duly served with copies of the Notice.

On May 3, 2007, Respondents filed a request for a hearing.

On May 9, 2007, by Procedural Order, a pre-hearing conference was scheduled on May 30, 2007.

On May 11, 2007, the Division filed a Motion to Continue the pre-hearing conference due to a previously scheduled matter which involves counsel for the Division.

On May 14, 2007, by Procedural Order, the pre-hearing conference was continued to June 7, 2007.

1 On May 24, 2007, Respondents filed a request to continue the pre-hearing conference
2 scheduled on June 7, 2007, due to business outside of Arizona.

3 Accordingly, the pre-hearing conference should be continued.

4 IT IS THEREFORE ORDERED that the pre-hearing conference scheduled on June 7,
5 2007, shall be continued to July 11, 2007, at 10:30 a.m., at the Commission's offices, 1200 West
6 Washington Street, Phoenix, Arizona.
