**ARIZONA-AMERICAN WATER
COMPANY COMPLIANCE
UPDATE**

1 In compliance with Decision No. 68917, Arizona-American Water Company ("Arizona-
2 American") was to "notice its customers that are provided wastewater service by the City of
3 Surprise of the tariff filing" Furthermore, Arizona-American must "file amended agreement
4 and tariff with Docket Control" as a compliance matter.

5 Arizona-American sent the notice in a form of bill inserts to its customers who receive
6 waste water service from city of Surprise in February, 2007. Arizona-American filed a copy of
7 the notice and affidavit of the person who sent the notice on April 30, 2007.

8 Arizona-American and City of Surprise staff amended the Water Service Termination
9 Agreement pursuant to the Commission's directions given in Decision No. 68917 on May 24,
10 2007. Arizona-American filed the amended agreement and tariff with the Docket Control on
11 May 31, 2007. Arizona-American is in full compliance with Decision No. 68917.




