Page 63, lines 12 and 13

STRIKE: "90/10 sharing provision was modified per APS' request to exclude certain types of costs"

INSERT: "90/10 sharing provision was eliminated"

Page 104, STRIKE lines 17 through 26 and INSERT:

Operating under the incentive provided by the 90/10 sharing mechanism, APS has been diligent in its fuel procurement.<sup>60</sup> Although the extent to which this diligence is the result of an "incentive" created by the existing 90/10 sharing mechanism is unknown, we do know that APS has demonstrated sound procurement practices. Accordingly, we will follow Staff's proposal by adopting a PSA that does not contain a 90/10 or any other sharing mechanism.

Although we will not implement a sharing mechanism that would potentially prevent APS from recovering the full amount of its necessary and prudently incurred fuel and purchased power costs, it is appropriate to put in place an incentive and controls to monitor and ensure that only prudently incurred costs are incurred on a timely basis. To exercise such control, we will require APS' fuel and purchased power acquisitions to be audited annually, as described herein, and until further order of the Commission. As an incentive, after notice and opportunity for hearing, the Commission may use the audit results to adjust the PSA rate.

Each annual audit shall be comparable in scope to the audit that we directed in Docket No. E-01345A-05-0827 and shall be performed by a Staff consultant and funded by APS. The period covered by each audit will coincide with the PSA year (February 1 through January 31), and the production and review of the audit results shall be scheduled in a manner that allows the audit results to be used in adjusting the PSA rate, if warranted. Accordingly, APS shall provide all data relevant to the audit to Staff's consultant by each February 28, and Staff shall docket its Staff Report (resulting from the consultant's audit) by

each August 15. The Company shall file its comments on the Staff Report by each September 30. The Commission will act on Staff's recommendations before each December 31.<sup>61</sup>

<sup>61</sup> For example: The PSA year runs from February 1, 2008 to January 31, 2009. APS would provide all relevant data (for the PSA year running from February 1, 2008 to January 1, 2009) to Staff's consultant by February 28, 2009. The Staff Report (resulting from the consultant's audit) shall be filed by August 15, 2009. APS will file its comments on the Staff Report by September 30, 2009. The Commission will issue its decision on the matter by December 31, 2009. Any change to the PSA rate resulting from the Commission's decision will be incorporated into the PSA rate beginning February 1, 2010."
