Dear Mr. Grapp:

In reference to the above mentioned application filed on March 22, 2007, and the supporting documents filed on May 3, 2007, this letter is to inform you that the application still has not met the sufficiency requirements as outlined in the Arizona Administrative Code. The deficiencies are

1. Please provide a list of the assets that Serviceberry Water Company will be transferring to Vernon Valley Water, Inc.
2. For each well listed in the response to Item No. 1 above, please verify Company ownership according to Arizona Department of Water Resources records.
3. In Item T. of the Application, the Applicant indicated in its response "N/A". Staff is aware that the owner(s) and/or shareholder(s) of the Transferee has other public utility interest. Please provide the names and addresses of the public utility interest(s).

Staff would like to use this opportunity to bring the following to your attention:

- Pursuant to the Arizona Administrative Code ("A.A.C.") R-14-2-411(C), the time-frame for administrative completeness review shall be suspended from the time the notice of deficiency is issued until staff determines that the application is complete. Upon meeting sufficiency requirements, the Commission has 150 calendar days for its substantive review. This includes conducting a hearing and preparing Opinion and Order to present to the Commission at an Open Meeting.


