APPLICATION TO INTERVENE**

Arizona Water Company, an Arizona corporation, hereby applies for an order permitting it to intervene in the above captioned matter pursuant to A.A.C. R14-3-105. Arizona Water Company is directly and substantially affected by this proceeding. This application is based upon the following:

1. Arizona Water Company presently holds Certificates of Convenience and Necessity ("CCNs") issued by the Arizona Corporation Commission (the "Commission") for the purpose of providing water utility service in the City of Casa Grande and the surrounding areas of Pinal County, and has served customers within those CCNs since 1955. Arizona Water Company currently provides water service to more than 21,000 customers in its Casa Grande system and has invested more than \$72 million in gross utility plant in this system.
