PROCEDURAL ORDER

BY THE COMMISSION:

On August 22, 2005, Vanco Direct USA, LLC ("Vanco") filed with the Arizona Corporation Commission ("Commission") an application for approval of a Certificate of Convenience and Necessity ("CC&N") to provide resold long distance telecommunication services and resold local exchange services for the state of Arizona.

On April 27, 2007, Vanco filed an application for approval to inform the Commission of a transaction whereby Lloyds TSB Bank PLC will make available to Vanco and certain of its affiliates, the sum of 100 Million Pounds Sterling which will be secured by the guarantee of Vanco, a security interest in Vanco's assets and pledge of Vanco's membership interests.

On May 15, 2007, the Commission's Staff filed a Motion to Consolidate ("Motion") the above-captioned matters. In its Motion, Staff stated that the matters are substantially related and no

1 parties' rights will be prejudiced.

2 Accordingly, no objections have been filed and Staff's Motion should be granted.

3 IT IS THEREFORE ORDERED that Staff's Motion is hereby granted and Docket Nos. T-
4 20404A-05-0599 and T-20404A-07-0261 are hereby consolidated.


