PROCEDURAL ORDER

BY THE COMMISSION:

On March 16, 2006, Sempra Energy Solutions ("Sempra" or "Company") filed with the Arizona Corporation Commission an application for a Certificate of Convenience and Necessity to provide competitive retail electric service.

By Procedural Order issued April 13, 2007 as modified by Procedural Order issued April 30, 2007, a hearing date and associated procedural deadlines have been set for this proceeding.

On June 8, 2007, the Commission's Utilities Division Staff ("Staff") filed a Motion for Extension of time, requesting that the deadline for filing Staff's direct testimony be extended from June 11, 2007 to June 19, 2007 in order to allow sufficient time to address issues raised by the Court of Appeals' opinion in *Phelps Dodge*. Staff stated that it would not be opposed to a similar extension of time for other parties' filing deadlines.

Staff's request is reasonable and should be granted.

IT IS THEREFORE ORDERED that direct testimony and associated exhibits to be presented at hearing on behalf of Staff shall be reduced to writing and filed on or before **June 19, 2007**.

IT IS FURTHER ORDERED that **direct testimony** and associated exhibits to be presented at hearing on behalf of **intervenors** shall be reduced to writing and filed on or before **July 3, 2007**.

IT IS FURTHER ORDERED that all other procedural deadlines set forth in the April 30, 2007 Procedural Order shall remain unchanged.


