Applicant or any other party must request a hearing within twenty-one (21) days from publication of this notice, or the Commission will rule on the application without a hearing.

The application, report of the Commission's Utilities Division Staff and any written exceptions to the Staff Report prepared by the applicant are available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, Arizona 85007, and at ACCESSLINE COMMUNICATIONS CORPORATION, 11201 SE 8th Street, Suite 200, Bellevue, Washington 98004.

Under appropriate circumstances, interested parties may intervene in the proceedings and participate as a party. Intervention shall be in accordance with A.C.C. R14-3-105, except that all motions to intervene must be filed within twenty-one (21) days from the date of publication of this notice. 



