

Sempra Energy Solutions ("SES"), by and through its undersigned attorney, hereby responds to the Commission Staff's June 8, 2007 Motion For Extension of Time in the above-captioned proceeding. SES does not object to the proposed extension of time as it relates to the currently scheduled dates for the filing of the Commission Staff's testimony and exhibits, and the Intervenors' testimony and exhibits. SES does object to any extension of the currently scheduled July 19, 2007 date for the filing of SES' testimony and exhibits, and the currently scheduled July 31, 2007 hearing date. Representatives of SES, including its principal witness, have previously committed to vacation plans and related expenditures beginning in early August, and an extension of the hearing date could adversely impact them.
