**STAFF'S CLARIFYING EXCEPTIONS TO
THE RECOMMENDED OPINION AND
ORDER**

Pursuant to A.A.C. R14-3-110(B), the Arizona Corporation Commission Staff ("Staff") submits these Exceptions to the Recommended Opinion and Order ("ROO") dated June 6, 2007.

Staff respectfully requests to have certain language within the ROO changed. Specifically on page 48, starting at line 23, there is reference "that Staff's Compliance Division shall conduct annual odor detection site visits. . . "and on page 48, lines 24 1/2 and 27 1/2 the ROO again references "Staff's Compliance Division." Staff would like the references to "Staff's Compliance Division" to read "Utilities Division Staff" on each of those lines on page 48. Additionally, on page 48, line 24 1/2 after "December 31, 2007," begin a new sentence as follows: "This report should be filed until further order of the Commission.
