Operation of Mayes Amendment #8

- The annual change in the sum of all effective PSA rates can not be greater than +/- 4 mils.
- The PSA rates included in the application of the cap are:
 - The Forward Component
 - The Historical Component
 - Any and all Transition Components
 - The "Old PSA" Annual Adjustor
- The cap applies to each PSA year, which is defined as February 1 of each year through January 31 of the following calendar year.
- The bandwidth established by the cap is measured by summing all PSA rates that are effective at the end of each PSA year and adding/subtracting 4 mils from that sum.
- The first application of the 4 mil cap will be in February 2008 with the adoption of a new Forward Component and a new Historical Component.
- In extraordinary circumstances, the company may seek Commission authorization to exceed the 4 mil cap.

Operation of Mayes Amendment #8

- PSA rates in effect at 7/1/07 per prior Decisions and the Recommended Opinion and Order as modified by Mayes Amendment #8 are:
 - 4.0¹ mils – “Old PSA” Annual Adjustor continues collecting 2006 costs
 - 1.1² mils – Transition Component set to collect allowable 2005 Palo Verde outage costs over the July 2007 – June 2008 period
 - 0.0 mil – Forward Component
 - 0.0 mil – Historical Component
 - 5.1 mils – Total of PSA Rates in effect at 7/1/07 and in place at end of 2007 PSA year

- 2/1/08 – Next PSA Rate Change
 - 4.0¹ mil Old PSA Annual Adjustor expires
 - New forward Component based on projected 2008 costs becomes effective
 - New Historical Component to collect 2007 undercollections becomes effective
 - Maximum possible of all PSA Rates for 2008 per the 4 mil annual cap is 4 mils + the sum of all PSA Rates in effect at January 2008

- 6/30/08 – Transition Component Expires, no other known changes

- 2/1/09 – Next PSA Rate Change
 - New forward Component based on projected 2009 costs becomes effective
 - New Historical Component to collect 2008 undercollections becomes effective
 - Maximum possible of all PSA Rates for 2009 per the 4 mil annual cap is 4 mils + the sum of all PSA Rates in effect at January 2008

¹ Actual Adjustor is 3.987 mils.
