Dear Mr. Kaufman:

On May 30, 2007, Dancris Telecom, L.L.C. ("Dancris") filed an application to cancel their Certificate of Convenience and Necessity ("CC&N") to provide telecommunications services in Arizona. The Application submitted is not sufficient. This data request lists the information Staff needs to complete its analysis of your Application.

For purposes of this data request set, the words "Dancris", "Applicant", "the Company", "you", and "your" refer to Dancris Telecom, L.L.C., any representative, including every person and/or entity acting with, under the control of, or on behalf of Dancris Telecom, L.L.C. **For each answer, please identify by name, title, e-mail address, telephone number and address each person providing information that forms the basis for the response provided.**

These data requests are continuing, and your answers or any documents supplied in response to these data requests should be supplemented with any additional information or documents that come to your attention after you have provided your initial responses.

Please provide Docket Control with the information being requested within **10 days** of the date of this letter. Mail an Original plus 13 copies to Docket Control, Arizona Corporation Commission, 1200 W. Washington Street, Phoenix, AZ 85007-2927. If no response is received, Staff will recommend that the Application be terminated. If the Application is terminated, the Applicant cannot discontinue the telecommunications services that it is authorized to provide in Arizona, until such time as a new application is filed with and approved by the Commission.



- JFB1-2 Please indicate the reason(s) for the proposed discontinuance of services or abandonment of service area.
- JFB1-3 Please indicate the date and method you used to discontinued AOS telecommunications services in Arizona. Also, please furnish a list of the Aggregator(s) of your AOS service or a list of your AOS subscribers and locations served.
- JFB1-4 Please provide a copy of the legal notice of the Application to cancel telecommunications services in all counties affected by the Application. Counties affected are those counties where the Applicant is certificated to provide telecommunications services. Refer to Arizona Administrative Code ("A.A.C.") rule R14-2-1107.

- JFB1-11 Please indicate the number of residential and business customers the Applicant provided service to in Arizona. Also, provide a breakdown of the number of customers receiving telecommunications services by type of service. How many customers received AOS telecommunications services? How many customers received resold long distance telecommunications services in Arizona?
- JFB1-12 Please indicate if there are any affiliates of the Applicant currently offering telecommunications services in Arizona. If yes, are the telecommunications services provided by the Applicant similar to those offered by the Applicant's affiliates?
- JFB1-13 Please indicate if customers have been transferred to other telecommunications carriers. Indicate the telecommunications carriers the customers were transferred to and the number of customers in Arizona transferred to each carrier.
- JFB1-14 Please indicate the state(s) the Applicant currently operates in to provide telecommunications services to customers in Arizona.
- JFB1-15 Does the Applicant have conforming tariff(s) on file with the Commission? Please identify by type of service each tariff filed by the Applicant. If conforming tariffs not filed, please explain the reason(s) the tariff(s) are not filed with the Commission.
- JFB1-16 Does the Applicant have any employees in Arizona? If so, please list the number of employees by type of category (i.e. management, technical, and customer service).
