**NOTICE OF WITHDRAWAL OF  
AMENDED APPLICATION**

10 On June 8, 2007, Utility Source, L.L.C. (the "Company") filed an Amended Application  
11 in this Docket requesting an Effluent Tariff, which had not been previously requested or  
12 authorized.

13 On June 12, 2007 Staff filed a Response thereto and a Motion to Continue.

14 Administrative Law Judge Wolfe set a telephonic Procedural Conference on the matter  
15 for June 15, 2007.

16 All Parties, including the Intervenors, participated in the Conference Call.

17 At the conclusion of the Conference, the Company agree to withdraw the Amended  
18 Application and submit an A.R.S §40-367 tariff request for this previously un-offered service,  
19 namely Effluent Service, at a \$0.00 cost. It was agreed that that matter could be processed  
20 without suspension under the Statute, resulting in a 30 day effective date. It was further agreed  
21 that this Tariff Application would not need to be consolidated into the subject docket, nor cause a  
22 delay in the scheduled June 19, 2007 hearing in the Rate Case Application.
