On March 17, 2006, Qwest Corporation ("Qwest") and Interstate Wireless, Inc. d/b/a Handy Page ("Handy Page") filed an application for arbitration procedure and approval of an interconnection agreement concerning Wide Area Calling. In Decision No. 68993, The Commission ordered that Wide Area Calling is not a telecommunications service subject to arbitration under section 251 (b) of the Communications Act of 1934 as amended by the Telecommunications Act of 1996.

For purpose of this data request set, the words "Handy Page", the "Company", "you", and "your" refer to Interstate Wireless, Inc. d/b/a Handy Page and any representative, including every person and/or entity acting with, under the control of, or on behalf of Interstate Wireless, Inc. d/b/a Handy Page.
