NOTICE OF THE VERIFIED JOINT APPLICATION OF ESCHELON TELECOM, INC., AND INTEGRA TELECOM HOLDINGS, INC. FOR A LIMITED WAIVER OF THE PUBLIC UTILITY HOLDING COMPANIES AND AFFILIATED INTERESTS RULES AND FOR AUTHORIZATION TO ENCUMBER AND/OR MORTGAGE ASSETS OF ESCHELON TELECOM OF ARIZONA, INC., MOUNTAIN TELECOMMUNICATIONS OF ARIZONA, INC., AND ELECTRIC LIGHTWAVE, LLC

(DOCKET NOS. T-20527A-07-0202 AND T-03406A-07-0202) On March 29, 2007, Eschelon Telecom, Inc., ("Eschelon") and Integra Telecom Holdings, Inc., ("Integra") filed a verified joint application ("Application") with the Arizona Corporation Commission ("Commission") in Dockets No. T-20527A-07-0202 and No. T-03406A-07-0202 for a limited waiver of the Public Utility Holding Companies and Affiliated Interest Rules and for authorization to encumber and/or mortgage the assets of Eschelon Telecom of Arizona, Inc., ("Eschelon-AZ"), Mountain Telecommunications of Arizona, Inc. ("MTI-AZ") and Electric Lightwave, LLC ("ELI") located in Arizona. Integra intends to acquire all of the outstanding equity interests of Eschelon, resulting in Integra directly controlling Eschelon and its Arizona subsidiaries Eschelon-AZ and MTI-AZ. Integra will obtain loans to effectuate the acquisition that will be secured by the utility plant and assets of Integra's subsidiaries, and will encumber the plant and assets of Eschelon-AZ, MTI-AZ and ELI. In addition, Integra's subsidiaries, including Eschelon-AZ, MTI-AZ and ELI, will execute guarantees in connection with the loans.

The Commission will consider the Application at an upcoming open meeting. The Application is available for inspection during regular business hours at the Commission's offices at 1200 West Washington Street, Phoenix, Arizona 85007, and at the office of Integra at 1201 NE Lloyd Blvd., Suite 500, Portland, Oregon 97232.

Under appropriate circumstances, interested parties may intervene in the proceeding, and participate as a party. You may have the right to intervene in the proceedings, or you may make a statement for the record. Intervention shall be in accordance with A.A.C. R14-3-105. Persons desiring to intervene must file a written Motion to Intervene with the Commission and send such motion to the Company or its counsel and to all parties of record, and which at the minimum, shall contain the following:

- 1. The name, address, and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different than the intervenor.
2. A short statement of the proposed intervenor's interest in the proceeding (e.g. a customer of the company, a shareholder of the company, a competitor, etc.)
3. A statement certifying that a copy of the Motion to Intervene has been mailed to the Company or its counsel and to all parties of record in the case.

Intervention shall be in accordance with A.A.C. R14-3-105. If you have any comments, mail them to:


