STAFF'S MOTION TO CONSOLIDATE

The Arizona Corporation Commission Utilities Division ("Staff") moves, pursuant to R14-3-109(H), that the above-captioned Application for a Certificate of Convenience and Necessity ("CC&N"), Docket No. W-02450A-06-0626, be consolidated with the Hassayampa Utility Company, Inc. Application for an Extension of its Certificate of Convenience and Necessity to provide sewer service in Maricopa County, Arizona, Docket No. SW-20422A-06-0566. The issues in these matters are substantially related and no parties' rights will be prejudiced by consolidation. Counsel for the Applicants agrees with the Motion to Consolidate.

Further, Staff would respectfully request that the hearing set in this docket for August 28, 2007, be consolidated with Docket No. W-02450A-06-0626 be reset for August 20, 2007, or at a time convenient for the Hearing Division.
