MOTION OF R. LEE STEERS, JR.
FOR LEAVE TO WITHDRAW
AS ATTORNEY OF RECORD
FOR THE RESPONDENTS

Comes R. Lee Steers, Jr., attorney of record for the Respondents in the above-styled cause, and moves the Administrative Law Judge for leave to withdraw as attorney of record for the Respondents in the above-styled cause. In support of this motion, the undersigned would advise the Administrative Law Judge of the following:

(1) By the Fourth Procedural Order entered in this proceeding by the Administrative Law Judge on March 26, 2007, the evidentiary hearing previously scheduled in this matter was continued indefinitely, on the grounds, *inter alia*, that the respondent Phoebus Vincent Smith was then incarcerated in the State of Arizona pursuant to an arrest warrant issued from the State of California.

1 (2) As of this date, the respondent Phoebus Vincent Smith is now incarcerated in the
2 State of California, he having waived extradition from Arizona in order to answer the charges set
3 forth in an arrest warrant issued by the State of California.

4 (3) The Respondents retained their attorney in this matter on a time-and-expenses
5 compensation basis. The Respondents have paid their attorney all amounts due to be paid for his
6 services rendered to date. However, the Respondents have advised the undersigned that they are
7 unable to pay any additional attorney's fees in this matter, and that they are unable to represent to
8 their attorney and/or to the Administrative Law Judge that they will be able to pay additional
9 attorney's fees in the foreseeable future.

10 (4) The undersigned has communicated with the Respondent Sharon Elizabeth Govan-
11 Smith about this matter. The Respondent Sharon Elizabeth Govan-Smith has in turn communicated
12 with the Respondent Phoebus Vincent Smith about this matter. The Respondent Sharon Elizabeth
13 Govan-Smith has advised the undersigned that both of the individual respondents consent, and that
14 the respondent Believing In Jesus Investments, LLC, consents, to their attorney's withdrawal from
15 this representation, on account of the respondents' inability to pay any further attorney's fees.

16 WHEREFORE, the undersigned moves the Administrative Law Judge that he be granted
17 leave to withdraw as attorney for the Respondents in this proceeding.
