PROCEDURAL ORDER

BY THE COMMISSION:

On March 7, 2007, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against Owen A. Vilan and Lucina Vilan, husband and wife, and Saguaro Investments, Inc., fka Vilan Enterprises, Inc. ("SIVE") (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

Respondents were duly served with copies of the notice.

On April 9, 2007, Respondents filed a request for a hearing.

On April 12, 2007, by Procedural Order, a pre-hearing conference was scheduled for May 7, 2007.

On May 7, 2007, the Division and Respondents appeared through counsel. Counsel discussed the status of the proceeding and agreed to a status conference being scheduled in July. By Procedural Order, a status conference was scheduled in July 2007.

On July 11, 2007, the Division and Respondents appeared through counsel. Counsel are

1 discussing a possible settlement, and agreed to a status conference being scheduled in approximately
2 60 days.

3 Accordingly, another status conference should be scheduled in September 2007.

4 IT IS THEREFORE ORDERED that a **status conference** shall be held on **September 12,**
5 **2007, at 2:00 p.m.,** at the Commission's Office of Pipeline Safety, 2200 North Central Avenue, Suite
6 300, Phoenix, Arizona.
