

**TO THE COMMISSION:**


1. On June 27, 2007 the Commission issued a Procedural Order in the above docket scheduling IElement Telephone of Arizona's ("Applicant") pending application for a Certificate of Convenience and Necessity for hearing on August 15, 2007 at 10:00 a.m.
2. In its June 27 Procedural Order, the Commission instructed Applicant to publish notice of the hearing in a statewide Arizona newspaper by July 13, 2007 and to file Affidavits of Publication with the Commission by July 31, 2007.


