STAFF'S REQUEST FOR PROCEDURAL
CONFERENCE

The Arizona Corporation Commission Railroad Safety Division Staff requests that a procedural conference be set to discuss several issues presented by this application as well as matters related to appropriate notice to the public and the community entities that may be impacted by this application. Because the application is for four crossings rather than the more typical single application, there is an issue related to the advisability of evaluating all four crossings as part of a single application or whether it would be more appropriate to consider them individually. As a fallout of the resolution of this issue, the scheduling dates for hearing and the possible pre-filing of testimony and exhibits by the parties, will likely also be relevant to this application considering the expanded scope of this application relative to other application for at grade crossing upgrades.

Local Counsel for the applicant has advised the Commission's Legal Division that he would be out of his office until the end of July. Therefore Staff requests that the procedural conference be set after the end of July, at a time convenient for the Hearing Division.
