OBJECTIONS TO RECOMMENDED OPINION AND ORDER

CARL HARVEY DBA GOLDEN CORRIDOR WATER COMPANY DOES HEREBY FILE THE FOLLOWING OBJECTIONS TO THE RECOMMENDED OPINION AND ORDER ISSUED BY THE ARIZONA CORPORATION COMMISSION ON THE ABOVE REFERENCED DOCKET NUMBER.

GOLDEN CORRIDOR WATER COMPANY BEGAN AS A CO-OP AND WAS FORCED INTO CERTIFICATION IN 1985. THE HARVEY'S INVESTED IN IMPROVEMENTS TO FURNISH WATER TO THEIR CUSTOMERS TO THE BEST OF THEIR ABILITY. IN 2001 A SEVERE HEART ATTACK LEAD TO EMERGENCY OPEN HEART SURGERY FOR CARL HARVEY AND EVENTUALLY LEAD TO HIS FILING OF BANKRUPTCY. THE CHAPTER 7 EXHIBITS ARE ENCLOSED WITH THIS OBJECTION. AT THAT TIME, THE FEDERAL BANKRUPTCY COURT TOOK POSSESSION OF THE SOLE PROPRIETORSHIP, GOLDEN CORRIDOR WATER COMPANY.

AS OF JUNE 13, 2002, THE DATE OF DISCHARGE OF THE CHAPTER 7 (SEE EXHIBIT C-1), CARL HARVEY, WAS RELIEVED OF ALL PERSONAL RESPONSIBILITY FOR GOLDEN CORRIDOR WATER COMPANY. MR. RON ANCELL, BANKRUPTCY TRUSTEE, FAILED TO SELL GOLDEN CORRIDOR AND ON AUGUST 16, 2002 FILED THE NOTICE OF TRUSTEE'S INTENT TO ABANDON PROPERTY, (SEE EXHIBIT E-1)

CARL HARVEY HAS NO LEGAL RESPONSIBILITY FOR ANY THING TO DO WITH THE WATER COMPANY AFTER JUNE 13, 2002.

Dear Carl:

This will confirm that you may be contacting Mr. McCarville directly regarding the Keeling-Iles situation, in an effort to get that resolved. In addition, you will be contacting the City of Casa Grande regarding sale of the water company, in case they have an interest in obtaining the water operations directly as opposed to buying them at a greater price from Bill Little.

We also confirmed that your Chapter 7 Trustee, Ron Ancell, and Mr. Bill Little will be meeting with you at about 3:30 p.m. on Friday, June 7, 2002, to inspect the water company operations and assets. You indicated you would be willing to meet with them and show them around at that time. Mr. Ancell will be doing First Meetings of Creditors of other bankruptcy cases prior to meeting with you, and it might be easiest for you to simply meet him there, where you went for your First Meeting.

Finally, you have agreed to get the Ray Bontrager offer into escrow there in Casa Grande for the sale of the parcel in Eloy, on Sunshine Boulevard. I look forward to seeing that escrow proceed, and to getting that part of this case resolved, as well as getting some attorney's fees paid.


