

Cost Estimate for After Hours Work

In accordance with Schedule 1, Terms and Conditions for Standard Offer and Direct Access Service, Section 2.2.4, a customer will be required to pay \$75.00 per crew person per hour when the customer requests services that **do not** meet the definition of "service establishment" as defined in A.A.C. R14-2-203.D.3 (to install a meter, read a meter, or turn on service) and requires that the services be performed during a period other than regular working hours¹ (after hours, on a weekend day, or on a Company holiday).² Customers will be given notice of estimated charges prior to the work being performed.
